

# THE RULES OF ORDER

#### 1. RULES FOR RESOLUTIONS

- 1.1. Resolutions are submitted as the Canons may prescribe.
- 1.2. All resolutions shall be in writing and shall contain the name, parish, or mission, and the city of the proponent. Failing to meet the deadline as set forth in Canon 1, Section 9, the delegate or organization presenting a resolution may introduce such resolutions no later than an hour and a half after the opening of the Convention upon simple majority vote of the delegates. Except for resolutions contained in the reports of Convention Committees, no resolution offered after an hour and a half following the opening of convention (the deadline) shall be considered except upon the affirmative vote of three-fourths (3/4) of the delegates present and voting. The delegate or organization presenting a late resolution is responsible for having 250 copies of the resolution reproduced on blue paper for distribution to the Convention. and for sending an electronic copy (in docx or PDF format) to the secretary of convention.
- 1.3. The Presiding Officer shall refer all resolutions to appropriate Convention Committees for consideration, recommendation, and report to the Convention, provided, however, upon a vote of two-thirds (2/3) of the delegates present a resolution may be considered immediately.
- 1.4. Where two or more resolutions deal basically with the same subject, they shall be referred to the same General Resolutions Committee. The Committee shall make every effort to consolidate them or otherwise assure their compatibility and should also make every effort to obtain the concurrence of the proponents concerned.
- 1.5. Each Convention Committee to which a resolution has been referred, after providing for a public hearing thereon, shall consider the form and substance of the resolution and in making its report shall recommend (a) for adoption, (b) for adoption with amendment, (c) for adoption of a substitute drafted by the Committee, (d) for rejection, or (e) for discharge from further consideration because the subject matter has been included in another resolution. The Committee's recommendation to the Convention shall be in the form of a motion to adopt the Committee's recommendation. If the Committee recommends rejection, the motion shall be on the adoption of the resolution, notwithstanding the recommendation of the Committee for rejection. After this motion has been seconded, the Committee Chairman or other representative shall state the reasons for the Committee's recommendation. Thereafter, the proponent of the original resolution which is the subject of the Committee's recommendation shall be recognized first if he/she so desires. Amendments may be offered, including an amendment to substitute the proponent's original resolution for the one recommended by the Committee.
- 1.6. Any resolution which would require financial resources for its implementation shall address, within the context of the proposed diocesan budget, the source of any financial resources required for its implementation.

#### 2. MOTIONS IN ORDER OF PRECEDENCE

- 2.1. The following motions shall have priority in the order listed. The mover cannot interrupt a member who has the floor, must be recognized, and the motion must be seconded. They are subject to the following rules:
  - 1.1.a. To adjourn or to recess
    - (1). not debatable, if unqualified
    - (2). not amendable

- (3). cannot be laid on the table
- (4). majority vote
- (5). The motion to adjourn shall always be in order, except that it shall not be offered when another member has the floor

# 1.1.b. To adjourn to Time Certain

- (1). debatable as to the time
- (2). amendable as to the time
- (3). cannot be laid on the table
- (4). majority vote

# 1.1.c. To Lay on Table or To Table

- (1). not debatable
- (2). not amendable
- (3). cannot be laid on the table
- (4). majority vote

#### 1.1.d. To Vote Immediately or at Time Certain, or to Extend Debate

- (1). not debatable
- (2). amendable, as to time, if a time specified
- (3). cannot be laid on the table
- (4). two-thirds majority vote

## 1.1.e. To Postpone to a Time Certain

- (1). debatable
- (2). amendable as to time
- (3). may be laid on the table
- (4). majority vote

# 1.1.f. To Commit or recommit to any Committee

- (1). debatable, except as to a Convention Committee
- (2). amendable as to the Committee to which to be sent
- (3). may be laid on the table
- (4). majority vote

#### 1.1.g. To Amend or To Substitute

- (1). Amendments and Substitutes are debatable only when Main Question is debatable.
- (2). One Amendment may be made to each independent; or separate portion of a Resolution; and the right to amend extends only to one Amendment of that Amendment and to a Substitute and one Amendment thereto.
- (3). A Substitute and its Amendment may be laid on the table, but cannot be otherwise voted on until the original matter is perfected.
- (4). majority vote
- (5). Neither the Substitute nor its Amendment shall be voted on (except to lay on the table) until the original matter is perfected.

#### 3. MOTIONS WITHOUT ORDER OR PRECEDENCE

- 3.1. The following motions have no order or priority, but are subject to the following rules:
  - 1.1.h. Appeal from Decisions of Chair
    - (1). debatable
    - (2). not amendable
    - (3). may be laid on the table
    - (4). majority vote. A tie vote sustains the Chair.
    - (5). must be made immediately after decision
  - 1.1.i. To take from Table
    - (1). not debatable
    - (2). not amendable
    - (3). cannot be laid on the table
    - (4). majority vote
  - 1.1.j. To Recall from Committee
    - (1). debatable
    - (2). amendable
    - (3). may be laid on the table
    - (4). two-thirds majority
  - 1.1.k. To Create Special Order of Day for a Particular Time
    - (1). debatable
    - (2). amendable as to time
    - (3). cannot be laid on the table
    - (4). two-thirds majority vote
  - 1.1.l. Call for Order of the Day
    - (1). Mover may interrupt a member who has the floor and is not required to be recognized or to have a second
    - (2). not debatable
    - (3). not amendable
    - (4). cannot be laid on the table
    - (5). No vote required, but two-thirds majority vote is necessary to suspend general or special order
  - 1.1.m. To Suspend the Rules or Take Up Business Out of Order
    - (1). debatable
    - (2). not amendable
    - (3). cannot be laid on the table
    - (4). two-thirds majority vote
  - 1.1.n. To Divide the Question
    - (1). not debatable
    - (2). can be amended
    - (3). cannot be laid on the table

- (4). majority vote, if vote required
- (5). may be made without being recognized and even though another member has the floor
- (6). If the Question under debate contains several distinct propositions which are independent of each other, at the request of any members the same shall be divided and a separate vote shall be taken, but the motion to strike out and to insert shall be indivisible.
- (7). If the propositions relate to the same subject, and yet each part can stand alone they may be divided only on a regular motion and vote.

#### 4. **RECONSIDERATION**

- 4.1. Neither a Question once determined, nor one of like import, shall again be brought before Convention, except on motion to reconsider made by one who voted in the majority, and seconded by another who voted in the majority.
- 4.2. Motions to reconsider are subject to the following further rules:
  - (8). debatable when motion to be reconsidered is debatable
  - (9). not amendable
  - (10). may be tabled
  - (11). two-thirds majority vote
  - (12). no question can be twice considered unless it was materially amended after its first reconsideration

#### 5. DECORUM AND DEBATE

- 5.1. No member shall be absent from Convention, unless given permission or be unable to attend.
- 5.2. No member shall address the Convention or make any motion until after recognition by the Bishop, except to make a parliamentary inquiry, a point of order, or a motion not requiring recognition.
- 5.3. When any Delegate is about to speak, the Delegate shall address the Bishop, state name, parish or mission, and be confined strictly to the point of debate.
- 5.4. Except by leave of the Convention, no Delegate shall speak more than twice in the same debate nor longer than five minutes at one time.

#### 6. VOTING

6.1. Nominations for Deputies to General Convention, Standing Committee, members of the Bishop and Council, members of the Dandridge Trust Board, which are in writing and contain the nominee's name, parish or mission, and city and not more than one hundred words of biographical information including past and present service of the nominee to the Church at all levels and received in the office of the Secretary fifteen days prior to the opening of convention shall be included in the Convention brochure, except for nominations to the Bishop and Council to be received at the caucus of convocations pursuant to the Order of Business.

Additional written nominations for these offices may be made in like manner by filing with the Secretary of Convention before noon of the day prior to the opening of the convention. All such nominations shall contain the name, parish or mission, and city of the nominator who shall obtain the nominee's consent and willingness to serve prior to submitting the nomination.

Nominations may be made only by the Bishops of this Diocese, the Clerical and Lay Delegates, and any other person authorized by Canon.

- 6.2. Balloting for the offices set forth in 7.01 shall commence not earlier than 9:30 AM on the Friday of the Convention.
- 6.3. In elections of Deputies to the General Convention, members of the Bishop and Council, and members of the Dandridge Trust Board, elected members of the Cathedral Chapter, a majority of the votes cast shall be necessary for election. In all other elections, including that of Alternate Deputies to General Convention, a plurality shall suffice. If the Convention shall take up other business while ballots are being counted, such business may be interrupted for the report of tellers and additional ballots.
- Unless otherwise expressly provided, any rule requiring a specified majority shall be construed to mean the affirmative vote of the specified majority of the Delegates present and voting.
- 6.5. Ballots with more or fewer votes than there are positions to be filled shall be declared invalid.
- 6.6. A vote by orders shall mean a specific vote by lay and clergy delegates and shall require passage in each order. [See Article VI of the Constitution]
- 6.7. In the event that there are two nominees from the same parish or mission for the Standing Committee, or the Bishop and Council, the two candidates, regardless of order, may stand for election. The candidate receiving a majority and/or the highest number of votes shall be elected and the other candidates shall be declared ineligible for the office due to canonical restriction.
- 6.8. In the event that nominations might lead to the election of more than one (1) retired clergy person to the Bishop and Council -- as would be prohibited by the provisions of Canon 6, Section 7(b) -- the following Rule shall apply: (1) if a retired clergy person has been elected for the coming year, any further nominations of a retired clergy person will be ineligible for election to office due to canonical restriction; (2) if two or more retired clergy members receive a majority vote in a ballot, the candidate receiving the highest number of votes shall be elected; (3) the elections by the Annual Convention shall be concluded, and announced, before the missionary convocation elections are held; (4) if no retired clergy person has been elected at large, and if two (2) or more retired clergy persons are elected contemporaneously at missionary convocation elections, the Annual Convention will hold a run-off ballot between those so elected in order to elect a single retired clergy member of Bishop and Council and in their run-off ballot, a simple plurality shall suffice to elect, the provisions of general Rule 8.03 notwithstanding, and the missionary convocation or convocations then having no completed clergy election will reconvene and elect a clergy person to Bishop and Council before the adjournment of the Annual Convention; and (5) for clarity a "retired clergy person" shall be defined as a clergy member who is receiving pension payments from the Church Pension Group or a clergy person who is seventytwo (72) years of age.

# 7. COMMITTEE OF THE WHOLE

7.1. Whenever so ordered by a vote of the majority of members present the Convention may go Into Committee of the Whole for the consideration of any matter.

#### 8. UNANIMOUS CONSENT

8.1. By unanimous consent, any action may be taken that is not in contravention of any provision of the Constitution or the Canons.

#### 9. GENERAL REGULATIONS

9.1. Except with the express permission of the Bishop or when otherwise ordered by majority vote of the Convention, no books, pamphlets, or other printed matter may be distributed within the Convention Hall, or be placed on the seats or desks of the Delegates; but this prohibition shall not apply to Resolutions, reports, and other documents prepared or distributed by the Secretary of the Convention or to ballots for elections.

#### 10. ROBERT'S RULES OF ORDER

10.1. Except when in conflict with the Constitution and Canons, or any Rules herein contained, the latest edition of Robert's Rules of Order shall govern the interpretation of these Rules and procedures to be followed.

#### 11. AMENDMENTS

11.1. These rules may be amended at any time by a two-thirds majority vote of the members present.

The Standing Committee

The Standing Committee is composed of seven persons: four clergy and three lay persons (Confirmed Communicants in Good Standing). Members are elected for three-year, rotating terms. Members having served a full term on the Standing Committee are ineligible to serve again for a period of two years. Not more than one person from the same parish or mission, either clergy or lay, shall be eligible to serve on the Standing Committee at the same time except in instances in which such person transfers from one congregation to another during their term of office (gf. Art. 9). A person may not serve concurrently on the Bishop and Council and Standing Committee (gf. Canon 6 Sec. 7©). No person may serve concurrently on the Commission on Ministry and the Standing Committee (gf. Canon 8 Sec. 3).

#### Question Responses



The Standing Committee fulfills this role by offering support to the Bishop, overseeing the purchase or sale of church property, recommending the approval of persons for ordination, and other ecclesiastical and administrative tasks as may fall under the Committee's purview. Should the Bishop resign or retire, the Standing Committee receives that resignation and then serves as the Ecclesiastical Authority for the Diocese until a new Bishop is consecrated.

Theologically, the Standing Committee's composition of lay and clerical members represents the people of the Diocese coming together with the Bishop to see that Diocesan assets, both material and spiritual, are used in a way that increases the Diocese in numbers as well as in commitment to the faith.

2) How is your understanding of the mission of the church related to the office for which you are a candidate?

The Church is a construction zone, building disciples who learn to live and love like Christ, and who strive to make their own parishes outposts of the Kingdom from which they can serve their communities and the world. The role of the Standing Committee is to help the Bishop maintain a healthy diocesan ministry that supports the parishes in that work by providing sound counsel and advice that is deeply grounded in our faith in Christ.

The Standing Committee also gives the Bishop advice and consent as to any judicial sentence given to a clergy person. And in the absence of a bishop, it will serve as the ecclesiastical authority of the diocese.

As a council of advice, the Standing Committee is called on to find Godly wisdom on practical matters that are important to the life and functioning of the diocese and its parishes. Communal discernment and faithful stewardship of resources are also central to carrying out the responsibilities of the Standing Committee.

2) How is your understanding of the mission of the church related to the office for which you are a candidate?

Central to the mission of the church is to proclaim the Good News of God in Christ, to make disciples of Jesus, and to baptize them in the name of the Trinity. **RESOLVED**, That the 193rd Annual Convention of the Diocese of Tennessee use approved common terminology to describe "Anti-Racism Work" as "Dismantling Racism."

## **Explanation:**

The 81st General Convention of the Episcopal Church acknowledged the expansion of its focus beyond antiracism to racial reconciliation. The GC adopted and concurred passage of A036 to Amend Canons to Use Approved Common Terminology to Describe Anti-Racism Work, which amended terminology from "antiracism" to "dismantling racism." #### REPORT OF THE STANDING COMMITTEE ON CONSTITUTION AND CANONS

#### CANONICAL RESOLUTION I: A RESOLUTION TO AMEND CANON 15.3

Proposed by: The Standing Committee on Constitution and Canons

To: The 193rd Annual Convention of the Diocese of Tennessee From: The Standing Committee on Constitution and Canons

Pursuant to Canon 30 of the Constitution and Canons of the Episcopal Diocese of Tennessee, the Standing Committee on Constitution and Canons reports that it has met and is recommending to the Convention that Canon 15 Sec. 3 be amended to The Standing Committee on Constitution and Canons for the Episcopal Diocese of Tennessee recommends the adopton by Convention of the following:

#### **Text of Resoution:**

**RESOLVED**, Pursuant to Canon 30 Section 1 of the Constitution and Canons for the Episcopal Diocese of Tennessee the following is offered as a proposed alteration of Canon 15 Section 3 of said Constitution and Canons.

The current Canon 15 Section 3 reads as follows:

Sec. 3 Every Parish shall have an Annual Parish Meeting of its members in January of each year or in the preceding Calendar Quarter, the date to be set by the Vestry. Notice of time and place of the Meeting shall be announced at a service of public worship at least two weeks prior to the Meeting.

The proposed alteration to Canon 15 Section 3 reads as follows:

Sec. 3 Every Parish shall have an Annual Parish Meeting of its members no later than February 15 of each year or in the preceding Calendar Quarter, the date to be set by the Vestry. Notice of time and place of the Meeting shall be announced at a service of public worship at least two weeks prior to the Meeting.

#### **Explanation:**

The Standing Committee on Constitution and Canons offers this as a substitute for Canonical Resolution II below.

#### **REGARDING CANONICAL RESOLUTION III:**

The Standing Committee on Constitution and Canons discussed the matter at their January 6th meeting, and has subsequently discussed the resolution with the proposer, and recommends further study of the matter.

# CANONICAL RESOLUTION II: AMENDMENT TO CANON 15.3 OF THE EPISCOPAL DIOCESE OF TENNESSEE

**Proposed by:** The Rev'd Natalie B. Van Kirk

Parish: Good Shepherd, Brentwood

**RESOLVED**, That Canon 15.3 of the Episcopal Diocese of Tennessee is amended to change the required final date of a Parish Annual Meeting from January 31 to February 15.

#### **Explanation:**

- Currently, Canon 15.3 requires that every parish have an Annual Meeting in January of each year, or in the
  preceding quarter. Under this proposal the Canon would be changed to read that the Annual Meeting be
  must held before February 15, or in the preceding quarter. My reasoning is as follows:
- Holding the Annual Meeting in the fourth quarter of the year is impractical if the Stewardship Campaign
  does not conclude until sometime in November. In larger parishes, no matter what stewardship program
  is used, it is usually the last week of the year before all potential pledges are received. A fourth quarter
  meeting means a Parish cannot receive an accurate budget for the coming year. It will often mean that the
  budget presented will show a significant shortfall.
- Further, the Canons restrict the beginning of the fiscal year to January 1. This means that Annual Meetings held prior to January 1 cannot receive a full account of the expenses of the parish for the year.
- If, as it seems the Canons imply, a Parish is to receive a full accounting of the prior year's expenses and income, and an accurate budget for the coming year, this cannot be accomplished without sufficient time to close the accounts for the prior year and for the Vestry to approve an accurate budget for the coming year. Finalizing the necessary financial reports for the meeting can often take two weeks or more.
- Restricting the Annual Meeting to the month of January means there are effectively only one or two weekends in the month that can be used for an Annual Meeting. In larger parishes there is no possibility of obtaining a quorum for the meeting if it is held on a weekday evening so weekends are the only option.
- The first Sunday of the month is too soon to reasonably expect all books to be closed, budgets set, and for the Vestry to receive and approve those financial reports.
- Additionally, school is generally not back in session and with many families traveling, it is very hard to achieve a quorum for parish business.
- The Martin Luther King Day weekend is also a difficult weekend because of school breaks and families being away.
- Diocesan Convention is always held in January and so takes away part of one week's preparation time for the Annual Meeting.
- In most years, this leaves only the last weekend in January for a parish to schedule an Annual Meeting.
- Moving the date to February 15 allows for a full reporting of the prior year's finances and a final budget to be presented to the parish. This increases transparency and accountability regarding parish finances.

# CANONICAL RESOLUTION III: AMENDMENT OF CANONS 15.4 AND 15.9 OF THE DIOCESE OF TENNESSEE

**Proposed by:** The Rev'd Natalie B. Van Kirk

Parish: Good Shepherd, Brentwood

**RESOLVED,** That Canon 15.4 of the Episcopal Diocese of Tennessee is amended to change the language defining who is eligible to vote at Parish Meetings from "Confirmed Communicant in Good Standing," to "Communicant in Good Standing," and be it further

**RESOLVED** that Canon 15.9 limiting Vestry membership to "Confirmed Communicants in Good Standing," be changed to "Communicant in Good Standing."

#### **Explanation:**

- The current Diocesan requirement that voters at an Annual Meeting and Vestry members be Confirmed has
  the negative effect of limiting interest in Annual Meetings and narrowing the possible selection of parish
  leadership to a much smaller number of people than the number of communicants in good standing in the
  parish. This can create the unintended perception that parish leadership and decision making is limited to a
  favored few.
- Making this change will align the selection of parish leadership and decision making more closely with the definition of full membership in the parish found in The Episcopal Church's national canons.
- Title 1.17.3 of the Canons of the Episcopal Church defines Communicants in Good Standing as follows, "All communicants of this Church who for the previous year have been faithful in corporate worship, unless for good cause prevented, and have been faithful in working, praying, and giving for the spread of the Kingdom of God, are to be considered communicants in good standing."

and

- Title 1.14, "Of Parish Vestries," no longer requires that Vestry members be Confirmed Communicants in Good Standing but leaves the terms of Vestry membership to the various dioceses.
- Therefore, it seems sensible that the requirement for Confirmation be removed from the Diocesan canons as it is neither a requirement for parish membership nor Vestry membership.
- Many clergy and dioceses no longer emphasize or encourage adult members who transfer into a parish to
  be confirmed or received by the Bishop. In larger, growing parishes, in areas where people move frequently,
  it is often difficult if not impossible to get parish records transferred from a previous parish, or to convince
  new adults from traditions that do not observe confirmation that confirmation is important.

Fair Share Commitments remain the primary source of income for the Diocese. The 'Ask' of congregations is equal to 10% of their operating income, calculated on a three year average. Reflected here is the total commitment of each congregation.

Funds held at the Episcopal Endowment Corporation (EEC) generate quarterly distributions, which is represented in the investment income lines. Distributions are calculated at 4% of a 3 year rolling average of year end investment values.

Former STEM churches will be operating independently under a new model in 2025, therefore STEM income will not be received.

Lease income represents rent from the cottage located on the property at the Diocesan House. This income is transferred to the EEC annually.

#### BISHOP'S LETTER REGARDING FAIR SHARE

Dear Clergy, Vestries, and Mission Councils,

On behalf of the Bishop and Council of our Diocese. I write to present this year's Fair Share request to your congregation.

The Fair Share offerings contributed by our parishes and missions constitute the largest and most significant source of support for our shared mission and ministry in Middle Tennessee. Without the robust commitment of our congregations, our work together would be impossible. The Faithful and Focused Annual Fund, and income from endowment and other sources, provide necessary support, but the Fair Share contributions are the most vital part of our annual budget.

Several decades ago, our Annual Convention made the decision to set our Fair Share request at 10% of a three-year rolling average of congregational income. This asking is significantly lower than in many dioceses of our Church. The Convention wisely decided to keep our resources at the most local level, to enable the good work of our congregations. The Fair Share is also a voluntary system, to avoid the burden of an exemption process, or the imposition of penalties for non-compliance: again, different from some other dioceses. As St. Paul writes, the Lord loves a cheerful giver (2 Corinthians 9:7).

At present, the Diocese of Tennessee is fully compliant with the mandatory Assessment from the Episcopal Church, which is set at 15%. For the better part of a decade, the Diocese has absorbed the difference between these two percentages. We build our Diocesan budget by first committing to the Episcopal Church. We give thanks to the Lord Jesus Christ for our ability to do this.

Though our Fair Share is a voluntary system, our Diocese is dependent on our congregations for acceptance of their share. Without that support our mission is weakened. Most of our congregations are honoring the Fair Share request at the full asking; others are taking steps toward meeting this request. The difference between what we request and what is given, however, remains significant, with immediate impact on the ministries that we can undertake together.

I ask you and your congregational leadership to review the history of your Fair Share commitment to the Diocese of Tennessee, prayerfully and intentionally, and to build your budget around it. We also ask you to respond in a timely way so that our budget planning can move forward. God has blessed our congregations with abundant resources, more than enough for the mission and ministry that we are called to. There are some things that we can only do together as a Diocese, through the Fair Share offerings of our congregations.

Thank you for your attention to this vital part of our life together as a Diocese. I am grateful for your leadership. You remain in my prayers as we engage in this ministry together. In turn, I ask your prayers for all our clergy, lay leaders, and congregations in the Diocese of Tennessee.

#### THE EPISCOPAL ENDOWMENT CORPORATION


The Episcopal Endowment Corporation (EEC) is, among other things, an attractive investment vehicle for congregations in the Diocese of Tennessee and the Diocese of East Tennessee. In the context of planned giving and good overall stewardship, having secure investment options that offer a good return for your congregation is important. For more information, please contact Pete Stringer, Treasurer of the Diocese and Board Member of the EEC.

#### **Background Information**

The Episcopal Endowment Corporation was created by a gift from Mrs. Delia Baxter Robinson of Nashville upon her death on June 15, 1932. She was the wife of Augustus Hammond Robinson who was born on May 23, 1844 and died in 1919. The bequest from Mrs. Robinson is a permanently restricted gift and its legal title is "The Augustus Hammond Robinson Memorial Episcopate Endowment Fund." For some eighty years, this fund has supported the Episcopate. Moreover, it paved the way for the Dioceses of Tennessee and East Tennessee as well as many congregations to invest and hold long term funds.

The EEC ended 2023 with a market value of \$52.5 million. The Fund's performance continues to be a most attractive long term investment vehicle for both dioceses and their individual congregations. The EEC Board voted to continue the 4% spending rate into 2025. The amount available for distribution is based on the average of the previous three years year-end market value.

# REPORT OF THE BISHOP AND COUNCIL TO ANNUAL CONVENTION ON INTERIM ACTIONS RELATED TO THE BUDGET, AND REAL ESTATE TRANSACTIONS UNDER CANON 10

In accordance with Canon 6.12 of the Diocese of Tennessee, The Bishop and Council presents the following report to the Annual Convention on interim actions taken in 2024.

# January 6, 2024

- Bishop and Council approved listing Christ Church, Alto and Holy Comforter, Monteagle properties on the real estate market for sale.
- Bishop and Council recommended the 2024 Draft Budget for approval by the Annual Convention.

# March 16, 2024

- Bishop and Council approved St. Anselm's roof improvement project
- Bishop and Council approved the Use Agreement between St. James the Less, Madison and Bike Fun.

# May 11, 2024

 Bishop and Council approved the Use Agreement between All Saints', Smyrna and Stewart's Creek Recreational League.

#### August 24, 2024

- Bishop and Council approved land sale proposal as presented by the vestry of St. David's, Nashville.
- Bishop and Council approved the construction loan between St. Paul's, Franklin and First Horizon Bank.

#### October 12, 2024

• Bishop and Council approved Church of Our Saviour, Gallatin, to seek lending from Regions Bank or First Horizon Bank in an amount up to \$150,000 as a bridge loan to complete a construction project.

#### December 14, 2024

The 2025 Draft Budget was recommended for approval by the Annual Convention.

#### THE CATHEDRAL CHAPTER REPORT

On Saturday, June 1, 2024, the Cathedral hosted the Diocesan ordinations of Laura Lowndes, Kathy Pack, and Tabitha Lewis to the diaconate.

The Cathedral Chapter has continued to follow with interest the work of the Isaac Project at Christ Church Cathedral. Many members of the Chapter attended the Service of Repentance held at Christ Church on December 5, 2024. The Chapter is grateful for the Cathedral clergy, the Rev. Tabitha Lewis, and the many Cathedral volunteers for their work on this important service. This service marks the end of Phase 2 for the Isaac Project and discernment is ongoing for the next outward-facing phase of the project.

The Chapter has received regular updates regarding the ongoing construction at Christ Church Cathedral, which includes, as of the end of 2024, completed renovations of existing offices, children's classrooms, and parish gathering spaces, and the completion of the foundation work and steel framing of the new addition. The Cathedral anticipates completing the Capital Improvement Project in the fall of 2025.

#### THE COMMISSION ON MINISTRY REPORT

The Commission on Ministry "shall advise and assist the Bishop" in the implementation of the Canons of the Church concerning Ministry, "in the determination of present and future opportunities and needs for the ministry of all baptized persons," and "in the design and oversight of the ongoing process for recruitment, discernment, formation for ministry, and assessment of readiness thereof" (Constitution and Canon of the Episcopal Church).

With Ed Arning's retirement from the Commission on Ministry, we started the year with a change of leadership. Shelley Sircy was appointed as Chair by Bishop Bauerschmidt to begin her role following the annual diocesan convention. We also welcomed Heather Wills, our newest member.

Laura Lowndes and Kathy Pack were ordained to the Vocational Diaconate on June 1st. Tabitha Lewis was ordained as a Transitional Deacon on June 1st and ordained to the priesthood on December 11th, serving the church of St. Anselm's in Nashville.

In 2024, we had Chase Benefiel, Zach Berry, Brad Daugherty, and Heather Daugherty continuing the priesthood track. And, we have additional nominees who are either in their post-Vocational Discernment Committee interview stage or in the early stages of the Vocational Discernment Committee process.

The Commission on Ministry held several education sessions to enhance our knowledge on the Constitution and Canons of the Episcopal Church and our role in the discernment process.

#### THE DANDRIDGE TRUST REPORT

The Dandridge Trust is the primary outreach of the diocese. The fund primarily supports seniors and those in need, facilitates accessibility, and funds general outreach programs and ministries for non-profit organizations, parishes, and missions within the boundaries of the Diocese of Tennessee. Since its creation in 1986, the Dandridge Trust has allocated grants totaling more than \$3.3 million. The committee continues its good work of balancing annual funding with preservation of an asset that will allow the diocese to continue this work into the future. Members of the Board this year include the Rev'd Michael Whitnah (St. Paul's, Murfreesboro), the Rev'd Brian McVey (Church of the Advent, Nashville), Dr. Agatha Nolen (St. George's, Nashville), the Rev'd Charlie McClain (St. Matthew's, McMinnville), Heather Wills (St. Bartholomew's, Nashville), and Tamra Smith (Church of the Redeemer, Shelbyville). This year, the committee prayerfully considered the applications of 55 organizations and ministries that sought grants of \$397,950. The committee recommended that 34 organizations and ministries receive grants totaling \$106,041.

#### BELOVED COMMUNITY: COMMISSION FOR RACIAL RECONCILIATION

The Beloved Community Commission continued in 2024 to focus our efforts in two primary ways: formation and awareness building. We hosted a variety of events, organized in-person and virtual community building, and facilitated multiple educational opportunities. Our communications efforts offer e-newsletters to 270+ subscribers every other week. We have facilitated visits to parishes, connected the diocese to dismantling racism resources, facilitated book discussions and virtual gatherings, and met with clergy to discuss issues of racism.

We continue to be involved with NOAH - Nashville Organized for Action and Hope - and participate in events about local issues, such as the local Police Community Oversight Board, mass incarceration, the death penalty, and community organizing.

Our efforts continue to be focused on providing space for people to deepen their understanding of how racism manifests in our society and impacts our existence as the Beloved Community, by:

- leading education and training opportunities
- strengthening connections with churches already involved in the work
- rapidly building a foundation to accommodate increased interest
- raising conscious awareness

#### Dismantling Racism Training of the Diocese

Having received approval and affirmation from the 191st Diocesan Annual Convention to provide Anti-Racism Training in this Diocese, the commission continued to offer dismantling racism trainings for the Clergy of the Diocese, the Clergy licensed to officiate, Sr. Wardens, the Diocesan staff, the members of the Standing Committee, and the members of the Bishop and Council, and also anyone in the diocese wishing to participate.

In addition to training, the Training and Education sub-committee also met regularly to update and make revisions to the Participant's Guide and Facilitator's Manual. Revisions were made taking in consideration participant feedback and up to date information/resources. The newly revised curriculum version will now be used for trainings beginning January 2025. We are grateful for the guidance and assistance from Bishop Bauerschmidt, Canon Jody Howard, as well as Sandra Beld.

Here are some training-related statistics by the number for the year 2024:

- 3 Trainings offered throughout the Diocese
- 3 Locations of those 3 trainings includes parishes and the Diocesan House
- 10 Facilitators that the commission currently has
- 1 Parish who invited the commission to offer training for their entire vestry and/or staff
- 53 Participants who completed the one-day training in 2024
- 229 Participants who have completed the one-day training since 2022

# <u>Pilgrimage to Sewanee – Roberson Project</u>

In November, the Beloved Community Commission members had the opportunity to spend a Saturday on a Pilgrimage to Sewanee, Tennessee to learn about the Roberson Project. Launched in 2017, the Roberson Project at the University of the South is a teaching-focused initiative seeking to gather and give a more complete historical account of the university, the town of Sewanee, and all its people, shedding light on how slavery and its legacies have marked Sewanee's history. Dr. Woody Register, Professor of American History at Sewanee, and head of the Roberson Project, spent the day with commission members sharing the history of the Roberson Project on Slavery, Race, and Reconciliation, and the tremendous work being done in Sewanee.

#### **Other Commission Work**

#### Episcopal Diocese of West Tennessee

In early fall, a few members of the commission met with Bishop Phoebe Roaf, Bishop of the Episcopal Diocese of West Tennessee, and Emily Austin, Director of Communications & Community Engagement of the Episcopal Diocese of West Tennessee, to share the origin and history of the Beloved Community Commission of this diocese. We also exchanged ideas about the challenging work of dismantling racism.

#### 2024 - Celebrating the Past Year (2023-24)

Nine years ago, the Episcopal School of Nashville (ESN) opened its doors with a mission to provide an innovative and inclusive educational experience rooted in the Episcopal tradition. Today, ESN remains the only Episcopal school in Nashville serving students beyond Kindergarten, offering an exceptional 5-to-1 student-to-teacher ratio. Located in vibrant East Nashville, ESN provides a unique, community-centered environment where students learn and grow in one of the nation's fastest-growing cities.

As a school grounded in Episcopal values, we embrace diversity, compassion, and a deep commitment to ensuring that every child feels seen, supported, and loved. Our goal is to nurture joyful learners and foster the critical thinking, creativity, and collaboration needed to prepare students as future leaders.

ESN is committed to making a high-quality independent education accessible. Over 23% of our students are from families of color, and 38% receive need-based financial aid, supported by one of the most affordable tuition rates among Nashville's independent schools.

#### Highlights from 2023-24:

- Enrollment: Served 156 students from 23 zip codes in grades PreK through 8th.
- Faith Formation: Represented 10 Episcopal congregations; offered twice-weekly chapel services and religion classes (Old Testament, New Testament, and World Religions) for middle school students.
- **Financial Aid:** Awarded nearly **\$550,000** in need-based assistance to 38% of families, fostering a diverse and inclusive community.
- **Academic Success:** 100% of 3rd graders read at or above the national 50th percentile, with 94% of students school-wide meeting this benchmark (MAP testing, 2022-23).
- Strategic Update: In December, the Board of Trustees approved a transition to a **3K-6th** grade model starting in 2024-25 to ensure long-term success and sustainability (details available at the convention table).

At St. Andrew's-Sewanee School we enjoy a rich Anglican heritage. Our historic understanding of faith encourages openness and respect for other religious traditions while the school community remains grounded in the history, tradition, and liturgy of the Episcopal Church. Students are encouraged to find their own process to a faith that will provide them with a deeper understanding of life and service.

St. Andrew's-Sewanee School prides itself on maintaining a geographically, racially, religiously, intellectually, and socio-economically diverse student body. We are committed to making our superb college preparatory program available to deserving students.

Through an agreement with the University of the South, outstanding juniors and seniors are able to take college courses at no additional cost. In recent years, 32% of the senior class has graduated with college credit. St. Andrew's-Sewanee School challenges students to fulfill their greatest potential while cultivating lives of balance and joy.

Upper school students are required to complete 15 hours of community service for each year (grades 9-12) that they attend St. Andrew's Sewanee School. From dish duty in the cafeteria, to work in a local food ministry, to just being mindful daily of the needs of others, our service is born of our sense of responsibility for the community we live in. When students know one another and their neighbors, it's hard not to lend a hand when one is needed.

**2022-2023** Statistics for St. Andrew's-Sewanee School (August 2021 to May 2022) \*Collected on the 10th day of classes. Enrollment for August was 233 students which included 61 boarding-students and 172 day-students. The 2022-2023 student body represents 15 states and 11 countries.

The 2023 graduating class consisted of 39 seniors. The 39 members of the graduating class of 2023 received 102 acceptances to different colleges and universities.

- The Bishop is the shepard of the diocese and the Standing Committee is there to assist the Bishop's efforts with advice and different points of view.
- 2) How is your understanding of the mission of the church related to the office for which you are a candidate?

The church should view it as her mission to have a broad cross section of people from the diocese represented in the Standing Committee to ensure the voice and viewpoint of as many parishioners is incorporated in the advice given to the Bishop.
